SUBJECT : CREATION OF TASK FORCE TO FORMULATE AN OPERATING GUIDELINES ON COMMUNITY BASED FOREST PROTECTION AND LAW ENFORCEMENT.

2. Coordinate with DENR field offices, other government agencies and NGOs regarding the formulation and implementation of Community Based Forest Protection and Law Enforcement activities adaptable nationwide; and
3. To come up with a systematic methodology and mechanism for a Community Based Forest Protection and Law Enforcement to ensure successful implementation of Forestry projects under the Forestry Sector Project Loan (Loan II) of the DENR.




