The Project Steering Committee shall: (a) supervise and provide policy directions/guidelines in the implementation of the project; (b) facilitate/act on matters affecting inter-agency personnel involvement in the project; and (c) conduct

regular evaluation/review of the project's accomplishments and/or operational problems.

The National Technical Working Group shall: (a) provide technical expertise and assistance in the implementation of the project activities; (b) coordinate and/or conduct data collection and analyses for project report preparation; (c) supervise/monitor field implementation activities in cooperation with regional offices; (d) supervise the final preparation and printing of provincial ecological profile; and (e) acts as Secretariat to the Project Steering Committee.

To enable the Project Steering Committee and the National Technical Working Group/Secretariat to carry out their functions, a Regional Project Coordinating Teams shall be constituted in each of the regional office which will be headed by the respective RTD's for Research.

Members of the Project Steering Committee, the National Technical Working Group/Secretariat and the Regional Project Coordinating Teams shall be entitled to claim travelling expenses incurred in the conduct of the project activities charged to the Project funds, subject to usual accounting and auditing rules and embodied in the Amended Auditing Manual for Research Operations.

This Order shall take effect immediately.
