DENR SPECIAL ORDER NO. 5/3 Series of 1993

SUBJECT

AUTHORIZING THE CONDUCT OF A SERIES OF TRAININGS FOR LOCAL GOVERNMENT UNITS ON "CAPABILITY BUILDING FOR ENVIRONMENTAL MANAGEMENT PLANNING AND MONITORING, LAND USE PLANNING AND THE EIA PROCESS" AND THE ATTENDANCE OF DENR PERSONNEL TO SAID TRAINING

Pursuant to the Program Grant Agreement between the GOP and the USAID and to facilitate the implementation of the LDAP-DENR component, a second series of five (5) day trainings is hereby authorized to be conducted in the pilot provinces of Quirino, Zamboanga del Norte and Iloilo. The objective is to improve local government unit's capacity in environmental management planning and monitoring, land use planning and basic Environmental Impact Assessment process.

While the majority of the participants shall be the local government planning officers and other selected representatives from the LGU concerned (Provincial Planning and Development Coordinators and staff, Municipal Planning and Development Coordinators, representatives from line agencies, NGOs and the church) the following DENR Central and Regional personnel are hereby authorized to attend the said trainings:
