SUBJECT: AUTHORIZING THE FOLLOWING DENR PERSONNEL TO ATTEND THE MEETINGS OF THE COMMON CONTROL MAPPING WORKING GROUP FOR PROPER IDENTIFICATION OF SITES INVOLVING ENR-SECAL, NFDO, NAMRIA, NRMP AND ETC.

1.
