SUBJECT : Creation of Special Committee to Execute the Decision, dated October 02, 1991 of the Supreme Court on G.R. No. 89093 entitled: Poe Mining Association and Philex Mining Corporation versus Macawiwili Gold Mining and Development Co. Inc., and Omico Mining and Industrial Corporation

In the interest of the service and pursuant to the Decision, dated October 02, 1991 of the Supreme Court in the Case G.R. No. 89093 entitled: Poe Mining Association and Philex Mining Corporation versus Macawiwili gold Mining and Development Co., Inc., and Omico Mining and Industrial Corporation, a Special Committee to execute the said Decision of the Supreme Court is hereby created/constituted, composed of the following:

The Committee in furtherance to the Orders of Execution dated September 02, 1992, November 11, 1992 and March 11, 1993 issued by the Regional Executive Director, DENR-CAR affirmed in an Order, dated April 5, 1993 and the Restraining Order, dated April 06, 1993, issued by the Office of the President having been lifted on May 03, 1993, the Committee is hereby directed to:

1. Finally execute the Decision, dated October 02, 1991 of the Supreme Court;
2. Put Macawiwili/Omico as the prevailing party in actual possession of the 21.9 hectare area subject of the Supreme Court decision;



3. Upon putting the prevailing party in possession, the Committee shall assist, among others, to resolve the following issues:

- the request of Philex for easement of rights and recommend approval/denial thereof to the Secretary;

- if required, the assessment of the improvements found in the area together with a representative each from Omico and Philex;


- assist in the evaluation/settlement of the issue on just compensation in accordance with existing regulations on the matter; and

- if needed, plan and direct for the orderly removal/transfer of Philex facilities found therein.

4. The Committee shall perform such other vital tasks as may be required and proper under the premises.

In the pursuit of all the above, the Committee shall call upon any government agency/entity including the Provincial PNP, having been duly deputized to assist in the peaceful turnover and maintenance of peace and order in the area, if warranted.

This Order revoked Special Order No. 433 of 1993.
