




2. They shall report directly to the Forester III of their respective CENR Offices and shall be relieved of other functions. As PMOs they shall have the following functions/duties/responsibilities:

- a. Monitor the compliance of NGOs to the approved DENR-NGO Services Contracts;
- b. Provide technical assistance to the CFP-assisting NGOs and the community residents as the need arises;
- c. Assists NGOs in the preparation of Work and Financial Plans and source technical assistance for the NGOs and the community within the DENR and other resource institutions;
- d. Check the technical validity and integrity of key financial transactions of NGOs;
- e. Prepare and submit CFP monthly accomplishment report;
- f. Submit quarterly and annual CFP reports to include documentation/information needed by the Regional Distillation Groups (RDGs), Regional CFP Coordinators, and the CFP Secretariat;
- g. Establish, keep and maintain records of relevant information and documents about the CFP;
- h. Perform other related functions as may be assigned by their supervisor;




3. They shall be entitled to travelling expenses and other allowances chargeable to available CFP Funds subject to existing accounting and auditing rules and regulations.
