
3. Team Leaders shall be responsible for the submission of reports to the Senior Undersecretary through the Program Coordinator of Community Forestry Program.


4. All allowable expenses of the performance review/assessment shall be chargeable against available CFP funds subject to usual accounting and auditing rule/ regulations.


5. This Order takes effect on May 11, 1993 (schedule of activities is attached).


