CREATION OF A MULTI-SECTORAL COMMITTEE INVESTIGATE/ASSESS/EVALUATE THE COMPLAINTS OF RODRIGUEZ, RIZAL ECOLOGICAL PROTECTION CRUSADE, INC. AGAINST THE QUARRY OPERATIONS IN LOCALITY OF RODRIGUEZ, RIZAL,

The Multi-Sectoral Committee shall further conduct studies on the following aspects or issues and shall submit to the DENR Secretary, through the Rizal Provincial Mining Regulatory Board, a report with its corresponding recommendations, within thirty (30) working days from the issuance of this Order:

- Environmental impact vis-a-vis the socio-economic contribution of the quarry operations in the area involved;
- Existing and/or most suitable land use of the area involved vis-a-vis the real intent of Proclamation Nos. 1636 and 1637; and
- 3. Tenural Problems in the area.

This Order takes effect immediately.
