**SUBJECT : AUTHORIZING THE CONDUCT OF MID-YEAR
PLANNING WORKSHOP OF THE NATURAL
RESOURCES MANAGEMENT PROGRAM-PROGRAM
SUPPORT OFFICE (NRMP-PSO)**
