Defining the Functions and Designations of Certain Personnel
Following the Issuance of Special Order 113 Series 1994

In the interest of the service and to further strengthen Special Order 113 S.1994, the designations and functions of the following personnel are hereby defined.

1. Director Al Rashid Ismael al Hadj. His primary function shall be to direct planning and coordinate for and upon directions of the Undersecretary for Field Operations, regional operations in the Visayas and Mindanao. As such, he shall carry the functional designation of "Planning Director, Regional Operations, Visayas and Mindanao, Office of the Undersecretary for Field Operations". His secondary function, related to his primary function of Planning Director for Regional Operations, Visayas and Mindanao, shall be as Department Liaison for the Autonomous Region of Muslim Mindanao (ARMM); As such, he shall receive directions from the Secretary to undertake such actions and activities as the Secretary directs him to do. As National Coordinator for the Coastal Environment Program, he shall, likewise, function as directed by the Secretary, focusing his efforts on establishing a similar program in ARMM.
2. Director Mariano Valera. His primary function shall be to direct planning and coordinate for and upon the directions of the Undersecretary for Field Operations, regional operations in Luzon. As such, he shall carry the functional designation of Planning Director, Regional Operations, Luzon, Office of the Undersecretary for Field Operations".
3. Assistant Director Jesus Sarile. His primary function shall be as Assistant Director, Public Affairs Office. As such, he shall assist the the Director, Public Affairs Office, but focusing his efforts on coordinating the externally-funded IEC activities of the Department except the FAO-DENR Upland-Population IEC Program. His secondary function shall be as Communications and External Affairs Director, Office of the Undersecretary for Field Operations. As such, he shall receive directions from the Undersecretary for Field Operations to discharge tasks and responsibilities related to field operations IEC and to external affairs matters of the Department. As Program Coordinator of NRMP, he shall assist the Director on matters related to NRMP and as directed by the Senior Supervising Office of NRMP.

Director Sarile is hereby directed to immediately report to the Director, Public Affairs Office, to define with him the scope of his task as foreign-funded IEC programs; he is likewise directed to report for the Undersecretary to Field Operations where he is to hold his primary station.

4. RTD Sydicious Panoy. He shall report to the Regional Executive Director, Region 4, to ensure the function and designation of Regional Technical Director, Land Management Service, Region 4, vice RTD Felipe Sison who is retiring.

This order shall take effect immediately and shall be in force unless revoked in writing.
