**SUBJECT: Conduct of a Nationwide Field Validation of DENR 1993 Accomplishments of Major Programs and Projects**

In the interest of the service and in compliance with Administrative Order No. 33, Series of 1992, prescribing the Standard Operating Procedures for Performance Monitoring, a nationwide field validation will be simultaneously conducted from 07 - 26 February 1994. This validation intends to verify the accuracy of the reported accomplishments, identify the causes of slippages in the performance of the activities and recommend possible solutions/recommendations to be taken; and assess the effects of the accomplishments of the DENR's major programs/projects to its intended beneficiaries.

The validation process shall involve both office verification and field validation exercises which include investigation, documentation and analysis of results, documentation of recommendations and update of regional records/master files. To carry out this task, composite validation teams shall be created to be composed of representatives from the Planning and Policy Studies Office (PPSO), Bureaus and Regional Offices. All Regional Planning Officers should be designated as Team Leaders and shall report directly to the Chief, Project Development and Evaluation Division (PDED) who will in turn report the activities of the validation teams to the undersigned.

The validation team shall be free to call on any regional/field personnel to assist them in the pursuance of the said activity.

Validation reports shall be discussed and presented to the reporting officers/CENRO/PENRO/Regional Technical Directors/Regional Executive Directors immediately after the validation and before leaving the office. Final reports shall be submitted to the Undersecretary for Natural Resources and Management and Undersecretary for Field Operations upon arrival.

All expenses to be incurred in connection with the assignment shall be charged against the DENR - Central Office funds subject to the usual accounting and auditing rules and regulations.


All participants shall be relieved from their current assignment during the entire validation period.


