In the interest of the service and in order to effectively and efficiently implement DENR Administrative Order No. 10, Series of 1994, re: Revised DENR Statistical Reporting System, a 3-Day Workshop to assess the implementation of statistical reporting system and updating of DENR Statistical Calendar 1996-1998 is hereby authorized to be held at Casablanca Hotel, Legaspi City on April 3-5, 1995. The participants of the said workshop shall consist of personnel from Central Office, Staff Bureaus, Attached Agencies, Regional Offices and other personnel per attached list (see Annex "A").


All participants/officials are hereby authorized to claim reasonable travelling expenses and other allowable expenses that may be incurred while on official travel, chargeable against their respective offices and subject to the usual accounting and auditing rules and regulations. A registration fee of P 2,500 shall be charged per participant payable to DENR Region 5.

Expenses for the supplies and materials, food and accommodation (Partial) and other expenses shall be chargeable against funds allotted for "Statistical Services" (PPA-IID), subject to the usual accounting and auditing rules and regulations. DENR Region 5 shall take charge of all administrative arrangements and financial matters attendant to the said workshop, including arrangements for equipment, food, venue, transportation and designating of Special Disbursing Officer for the workshop, if necessary.

This Order shall take effect immediately and shall be in force for the duration of the workshop herein specified.
