As such, the above-named Officials are hereby directed to immediately clear themselves of their accountabilities/responsibilities from their present assignments and turnover the same to their successors or to any authorized accountable officials within their respective offices. Bringing of service vehicles and equipment to their new areas of assignment is strictly prohibited.


All current REDs/RTDs including OICs not in the above list shall report to the Undersecretary for Field Operations for assignments.

All the foregoing officials not occupying RED or RTD position are designated Officers-In-Charge (OICs) and are hereby authorized to claim Representation and Transportation Allowances (RATA) subject to existing rules and regulations.

For the charging of salaries and RATA, existing arrangements shall prevail until revised by the Undersigned. Likewise, disbursement of savings from salaries and RATA for unfilled RED and RTD positions in their respective Regions shall not be allowed unless cleared by the Undersigned.

All proposed amendments to this Order shall be submitted to the Undersigned through the Undersecretary for Field Operations and the Assistant Secretary for Management Services.

This Order shall take effect Immediately and supersede/ revoke all Orders inconsistent herewith.
