In the interest of the service and pursuant to the promotion of Gender and Development (GAD) concerns in the Department, the conduct of Gender Sensitivity Training (GST) in DENR Regions 4, 6, 7, 8, 9, 10, 11, 12 and 13 hereby authorized to be participated in by the following DENR personnel:
