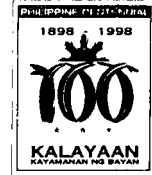



This Order shall take effect on the abovesited duration.


