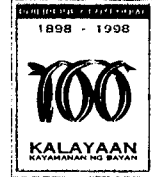

**SUBJECT: AUTHORIZING THE CONDUCT OF TURN-OVER ASSESSMENT WORKSHOP OF THE LOW-INCOME UPLAND COMMUNITIES PROJECT (LIUCP) ON OCTOBER 15-17, 1997 AT NASUGBU, BATANAS**

In the interest of the service and in view of the completed status of field-level management turn-over of the Project to the Local Government Units (LGUs) and respective PENROs, the Low-Income Upland Communities Project (LIUCP) is hereby authorized to conduct a three-day assessment workshop on October 15-17, 1997 at Nasugbu, Batangas.

The Workshop to be held at White Sands Hotel and Beach Resort shall have the following objectives:

1. To clarify the roles and functions of the Project Coordinating Office in view of the turn-over of field-level management of the Project to the respective LGUs and PENROs of both provinces;
2. To review the existing Monitoring and Evaluation System and formulate appropriate design for the current set-up;
3. To assess the implication of the turn-over to the current organizational and functional set-up and define individual and unit functions to address the needs and gaps; and
4. To formulate action plan indicating support strategies in carrying out field activities.


