SUBJECT

CREATION OF INTER-AGENCY COMMITTEES AT THE ENVIRONMENTAL MANAGEMENT

BUREAU

In the interest of the service and to effectively carry out the functions of the Environmental Management Bureau as mandated in Executive Order No. 192, Section 16 (h) and (i), the following committees are hereby created:

A. Inter-Agency Committee on Environmental Education

This Committee shall have the following functions.:

- To provide policy directions in the implementation of the National Environmental Education Action Plan;
- To oversee the implementation of the said Plan;
- To periodically assess the status of environmental education in the country, and recommend measures/programs/projects/activities whereby aggressive and active environmental education campaigns can be pursued/implemented.

This Committee shall be composed of representatives from the following:

- Department of Education Culture and Sports and the relevant bureaus/offices
- Commission on Higher Education
- Technical Education and Skills Development Authority
- Philippine Information Agency
- National Economic and Development Authority
- Department of Environment and Natural Resources
- Selected Universities
- Non-Government Organizations

B. Inter-Agency Committee to Prepare the updated Philippine State of the Environment Report

This Committee shall have the following functions:

- To develop methodologies for the preparation of the report;
- To provide information inputs to the various sectors of the report;
- To prepare the substantive content of the report;
- To review and validate the various aspects of the report;
- To recommend policies/measures to prevent and mitigate environmental problems

This Committee shall be composed of technical experts from the following disciplines:

- Forestry
- Biology
- Ecology
- Environmental Management
- Mining Engineering
- Disaster Management
- Pollution Prevention
- Institutions and the Environment
- Urban Planning

Authority is also granted for the payment of the honorarium to the members of the Committees and their support group from the Environmental Management Bureau, subject to the approved rates of the Department of Budget and Management.
