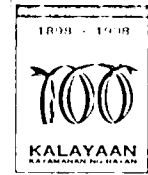

The member-coordinators, in addition, shall be responsible for coordinating the inter-agency activities as well as the schedules of different events during the actual tournament season.

The designated chairpersons of the different events/games are authorized to have three (3) other members to assist them in the conduct of the games. They shall spearhead the implementation of each game/event such as the place, schedule, set of official referees, ground rules, use and rental of sports equipment and materials, and provision of appropriate awards.

A budget proposal to cover expenses of coordinating activities shall be submitted to the Steering Committee who will recommend its approval. At the close of sports competitions, an accounting of expenses incurred shall be submitted also to the Steering Committee.

All DENR officials and employees shall extend all possible assistance to the two (2) Committees whenever necessary and they shall be authorized on official time to watch and participate in any or all of the events.

This DENR Inter-Bureau/Offices Tournament shall be for the period from March 10 until May 16, 1997.

This Order shall take effect immediately.
