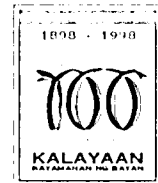

SPECIAL ORDER
No. 97- 211

SUBJECT: Authorizing the Conduct of an ORIENTATION SEMINAR ON LAND USE PLANNING for the Local Government Units on March 11 and 12, 1997 at Los Baños, Laguna and Pasig City, respectively.

In line with DENR's efforts at contributing to sustainable development to provide assistance to local government units (LGUs) in land use planning, and in order to facilitate the implementation of the plans and programs of the Mt. Makiling Reserve Area and Laguna de Bay Commission as stipulated in Exec. Order No. 121, the conduct of an **Orientation Seminar for Land Use Planning for the LGUs** and other concerned parties on March 11, 1997 at Los Baños, Laguna and on March 12, 1997 at Pasig City, is hereby authorized.

The Seminar discussion shall focus on the terms of reference for contracting the preparation/updating of comprehensive land use plans (CLUPs) and zoning ordinances for LGUs. It shall aspire to instill to the LGUs the need to integrate environmental concerns in their land use and socio-economic policy planning and decision-making, which will serve as an important guide and thus assist the LGUs in preparing or updating their respective CLUPs.

The Seminar for the Provinces of Laguna and Quezon shall be held on the 11th of March at the IFC Training Hall at UP Los Baños, Laguna, while for the Provinces of Rizal, Batangas and Cavite shall be held on the 12th of March at the Amang Rodriguez Hall, Rizal Provincial Capitol Hall, Pasig City.

The DENR - Integrated Environmental Management for Sustainable Development (IEMSD) Programme shall provide the resource speakers for the Seminar.

All expenses to be incurred in relation to the conduct of the Seminar shall be charged to the Commission funds, subject to the usual accounting and auditing rules and regulations. The Seminar schedule including the list of participants, which is attached as Annex A, shall form part of this Order.

This Order shall take effect immediately and shall remain in force until the duration of the said Seminar.
