A registration fee of PESOS ONE THOUSAND SIX HUNDRED (P1,600.00) shall be charged per participant. Payment checks shall be made out payable to the Regional Executive Director, DENR-Region 8, Tacloban City and must be sent and received not later than Monday, 12 May 1997

The registration fees of the MFPC National Federation Executive Committee Officers shall be charged against the budget of the MFPC NTWG while their travelling expenses to and from the congress venue shall be charged against MFPC budget of the regions where their residences belong.

The registration fees and travelling expenses to and from the congress venue of the MFPC Regional, Provincial, Municipal, Barangay and City Chairmen shall be charged against the MFPC budgets of the Region, PENRO or CENRO where they belong.

The registration fees and travelling expenses to and from the congress venue of the MFPC National TWG officers and members and DENR Central Office participants shall be charged against the budgets of their respective offices.

The registration fees and travelling expenses of the MFPC Regional, Provincial and Municipal TWG Chairmen shall be charged against the MFPC budgets of their respective offices or mother units.

The registration fees and travelling expenses of the MFPC National TWG Secretariat shall be charged against the NTWG budget.

DENR Region 8 personnel designated to assist in the conduct and documentation of the congress are non-paying participants in the congress.

All funds disbursements for this purpose are subject to usual accounting and auditing rules and regulations.
