The Mobile Team shall perform the following functions:

- 1. Coordinate with the RED and other Regional Officials in the conduct of training on Land Use Update and other CBFM training;
- 2. Implement CBFM Training;
- 3. Prepare and submit report gathering the implementation of CBFM Training.

The Regional Director may designate other members of the Mobile Training Team as he may deem necessary.

The HRD Service shall monitor and evaluate the CBFM training conducted by the Mobile Training Teams from time to time to upgrade the capabilities of said teams.

Expenses to be incurred shall be borne by the Regional Offices subject to the usual auditing and accounting rules and regulations.

This Order shall take effect immediately.
