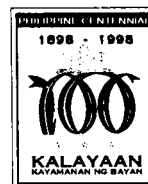

**SUBJECT : CONDUCT OF REGIONAL WORKSHOPS

MASTER PLAN (Framework, Strategy and
Action Plan) FOR MARINE AND COASTAL

In the interest of public service, the conduct of the Regional Workshop for the development of the Master Plan for Marine and Coastal Resources and Management at the Institute for Religion and Culture (IRC), Cebu City, on June 3-4, 1997, and at Mega Pension House, MegaHomes, Macasandig, Cagayan de Oro City on June 10-11, 1997, is hereby authorized.

The Workshop objectives shall be:

1. To bring together a core constituency of marine and coastal managers and stakeholders;

2. Suggested strategies on how these issues or pressures can be addressed;
3. Suggested actions on how to manage, protect and develop Philippine marine and coastal resources and environment;
