In addition to the evaluation of existing PLA/FLGLA, the Teams shall gather data about the existing land use(s) of all expired, terminated and canceled PLA/FLGLA.

The Cenro/Penro concerned are instructed to provide assistance in the form of transportation and access to records, to the Team(s),

All expenses of the Team shall be charged against their respective office' budget subject to the usual government accounting and auditing rules and regulations. Expenses of MFPC/NGO representative(s) shall be borne by the Regional Office.

The Review Committee is hereby created to evaluate the findings of the Teams and submit recommendation to this Office through the Office of the Undersecretaries. It will be composed of the following:
