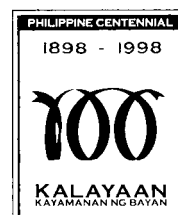

The **DENR Youth Desk** is composed of the SCO Director as Over-All Coordinator and the following as Desk Officers:

1. Ma. Magnolia Q. Danganan
2. Emily M. Schneider
3. Rommel R. Ariola

All **Regional Executive Directors** shall designate their respective **REGIONAL YOUTH DESK OFFICERS**, one permanent and one alternate, to develop, implement and monitor programs and projects to increase youth's participation in environment and natural; resources protection and management.

Duties and Responsibilities:

The **YOUTH COORDINATORS/REGIONAL DESK OFFICERS** are tasked to:

1. develop, implement and monitor programs, projects and activities that will enhance active participation of the youth sector in environment and natural resources concern;
2. facilitate and extends assistance to the youth on matters pertaining to environmental conservation, development and management;
3. coordinate with **SCO YOUTH DESK** on all programs, projects, activities, and other relevant information on youth concerns.


The **SCO YOUTH DESK** shall convene the **YOUTH COORDINATORS** at least once a month, and the **Regional Youth Desk Officers** at least twice a year, to discuss plans and programs for the youth sector.

The **SCO YOUTH DESK** shall coordinate, monitor, and extend assistance to the **Youth Coordinators/ Regional Youth Desk Officers**.

The Undersecretary for Environment and Programs Development, shall conduct as the adviser of the **YOUTH DESK OFFICERS/COORDINATORS**.

All expense to be incurred related to youth activities shall be sourced from their respective offices.

This Order takes effect immediately.
