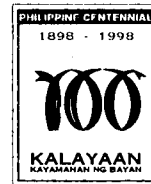

SUBJECT : Authorizing the Conduct of a CAPABILITY-BUILDING SEMINAR/WORKSHOP FOR SUSTAINABLE LAND USE PLANNING from July 13 to 20, 1997 at the Institute of Forest Conservation Training Hall in Los Baños, Laguna

In line with the implementation of the Mt. Makiling Reserve Area and Laguna de Bay Region Master Plan, as mandated by Executive Order No. 349, particularly in the Regional Land Use Planning component, and in order to come up with a workable and environmentally sustainable land use scheme for the subject areas, the Mt. Makiling Reserve Area and Laguna de Bay Commission (MMRALBC) is hereby authorized to conduct a **Capability-Building Seminar/Workshop for Sustainable Land Use Planning** from July 13 to 20, 1997 at the Institute of Forest Conservation Training Hall in Los Baños, Laguna. This Seminar shall also serve as a follow-up activity to the Orientation Seminar on Land Use Planning conducted last March 11 and 12, 1997, and, shall be participated in by representatives from various government offices and local government units listed in Annex 1.

The seminar shall focus on the tools and techniques in the preparation of sectoral land use plans as well as integrating these in the municipal comprehensive land use plan in a sustainable planning and development framework. The seminar's timetable of lectures, discussions and activities is hereby attached as Annex 2.

Expenses to be incurred, including accommodations and meals will be charged to the Commission funds, subject to the usual accounting and auditing rules and regulations.

This Order shall take effect immediately and shall remain in effect until the duration of the said Seminar.
