SUBJECT: Nationwide Orientation-Workshop to Facilitate the Implementation of

the Eco-Labelling Project

Pursuant to the Joint Memorandum Circular signed by Secretary Robert Barbers of the Department of Interior and Local Government (DILG) and Secretary Victor Ramos of the DENR, respectively, concerning the Implementing Guidelines for the Eco-Labelling Project "MAKABAYAN" (*Makakalikasang Bayan*), and in consonance with the decision reached during the Management Conference (MANCON) last July 17-19, 1997 at Laoag City to pursue its implementation, a Nationwide Orientation-Workshop for the Eco-Labelling Project shall be conducted.

A. OBJECTIVES

- 1. To clarify the background and concept of the project;
- 2. To clarify substantial and procedural aspects of the project; and
- 3. To facilitate compliance to the implementation of the project.

B. PARTICIPANTS

All Planning Officers of all Regions, PENROs and CENROs are required to attend the Orientation-Workshop. They are likewise instructed to orient the Planning Officers of the concerned Local Government Units (LGUs) and implement the Eco-Labelling Project in their respective areas of jurisdiction.

C. WORKSHOP SECRETARIAT

The Special Concerns Office (SCO) and the Integrated Environmental Management for Sustainable Development Program (IEMSD) shall conduct, and serve as Secretariat of, the Orientation-Workshop. All necessary information materials shall be provided by the said offices.

For practical purposes, two (2) teams shall be organized to conduct the Orientation-Workshop covering all regions.

D. FUNDING

All expenses to be incurred in the conduct of the Orientation-Workshop of the Eco-Labelling Project and its subsequent implementation shall be charged against available funds of the respective DENR offices.
