SUBJECT : AUTHORIZING THE PARTICIPATION OF THE MEMBERS OF THE PHILIPPINE JOINT MANAGEMENT COMMITTEE AND SOME PAWB PERSONNEL IN THE PLANNING SESSION OF THE TECHNICAL WORKING GROUP FOR THE MANAGEMENT PLAN OF THE TURTLE ISLANDS HERITAGE PROTECTED AREA TO BE HELD ON AUGUST 4-7, 1997, IN SUBIC, OLONGAPO CITY.


The members of the Malaysian TWG-MP is composed of the following:
