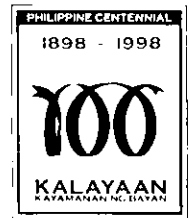

SPECIAL ORDER

SUBJECT: ORGANIZING AN EXECUTIVE OFFICE FOR THE PRESIDENTIAL COMMISSION FOR THE INTEGRATED CONSERVATION AND DEVELOPMENT OF THE SULU AND CELEBES SEAS (PCICDSCS)-TECHNICAL WORKING GROUP (TWG) AND STRENGTHENING ITS SUB-COMMITTEES

To effectively deliver the services called for by Proclamation No. 1028 declaring the Sulu and Celebes Seas as Marine and Coastal Integrated Conservation and Development Zone (MCICDZ) and creating the Presidential Commission for the Integrated Conservation and Development of the Sulu and Celebes Seas (PCICDSCS), an Executive Office for the PCICDSCS-TWG is hereby organized the Secretariat created under Special Order No. 97-939 is hereby dissolved.

The Executive Office shall be composed of the following:

Herein designates shall perform their functions in addition to their present work load. The Executive Office shall:

1. oversee the implementation of the Indicative and Operational Plans for the MCICDZ;
2. provide secretariat work for both the PCICDSCS and the TWG;
3. be responsible for all action documents of the PCICDSCS-TWG;
4. perform other related tasks as maybe assigned by the Head of the PCICDSCS-TWG.
5. Report to the Chairperson of the Commission when necessary or as required.

All pertinent records of the PCICDSCS-TWG shall be kept and maintained by the Executive Office.

To fast track the programs/ projects/ activities of Marine and Coastal Integrated Conservation and Development Zone (MCICDZ), the sub-committees of the Presidential Commission for the Integrated Conservation and Development of the Sulu and Celebes Seas (PCICDSCS)-Technical Working Group (TWG) are hereby strengthened.

Herein designates shall perform their functions in addition to their present work load. The Sub-Committees shall:

2. submit progress reports (following the completed staff work standards) to the Chairperson of the PCICDSCS-TWG attention the Executive Officer;
3. perform other related tasks as maybe assigned by the Chairperson of the PCICDSCS-TWG.

The sub-committee heads shall meet to finalize their respective operations plans for approval of the Head of the PCICDSCS-TWG not later than 1998 February 25.

Expenses to be incurred by the Executive Office and Sub-Committees shall be funded by the Sulu and Celebes Seas Fund, subject to the procedure set forth and pertinent accounting and auditing rules and regulations.

This Order shall take effect immediately.
