AUTHORIZING HOLDING OF MFPC NATIONAL TECHNICAL WORKING GROUP MEETING TO REVIEW AND ANALYZE RESULT OF NATIONWIDE ASSESSMENT OF MFPCs AND TWGs BY DENR REGIONAL OFFICES
