By virtue of this deputation, the above-named agents are authorized to assist the Department of Environment and Natural Resources and the local government unit of Quezon City in the apprehension of motor vehicles violating the emission standards and/or in the conduct of voluntary emission testing of motor vehicles.

They are also directed to submit copies of all reports of their activities for the day, within 24 hours, to the Officer-in-Charge of the Anti-Smoke Belching Program of the LGU of Quezon City for appropriate action.

They are further directed to submit monthly accomplishment report to DENR-National Capital Region (cc Metropolitan Manila Development Authority).

This deputation authorizes them only to exercise the power and authority conferred herein within the territorial jurisdiction of Quezon City and is not transferable.

This Deputation Order shall take effect immediately and shall expire on December 31, 1998 unless earlier revoked by this Office.
