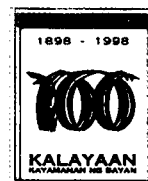


The participants are expected to give inputs on the activities to be undertaken to be able to implement the strategies under the WGs on Forestry and Environment Operational Plan CY 1998 as provided by the Philippine-EAGA Secretariat (MEDCo).

They are likewise expected to submit to the Secretary, copy furnished the Undersecretary for Environment and Program Development, Undersecretary for Field Operations and Assistant Secretary for Management and International Environmental Affairs, a comprehensive report on the actual activities/strategies to be undertaken by the TWG to accomplish the targets set under said Plan.

A registration fee of PhP1,500 shall be charged from each participant to cover the expenses to be incurred on food and hotel accommodation during the duration of the meeting chargeable against the funds of their respective offices subject to the usual accounting and auditing rules and regulations.
