SUBJECT: DESIGNATING FIRE MARSHALS/COORDINATORS
IN THE DENR CENTRAL OFFICE

In the interest of the service and pursuant to the implementation of the agency's Fire Safety and Disaster Preparedness Program, some DENR officials/personnel are hereby designated as Fire Marshals/Coordinators and shall perform the following functions:

1. Coordinate activities on fire safety and prevention;
2. Coordinate manpower/physical resources needed during emergencies;
3. Identify and assess fire prone areas within the Office and provide appropriate recommendations for actions to be taken by the concerned persons;
4. Prepare, update assist in providing fire exit markers for information and directional purposes;
5. Conduct an information education and communication campaign on fire safety and prevention ;
6. Assist in the actual conduct of fire drills and other safety measure; and
7. Enforce other fire safety measures that may be issued from time to time.
