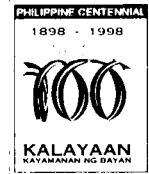

**SUBJECT : CREATION OF A TECHNICAL COMMITTEE FOR
THE SETTING OF STANDARDS FOR DIOXIN
EMISSIONS FROM INCINERATOR**

To enable the EMB to effectively discharge its mandated functions as provided for in Executive Order No. 192, a Technical Committee is hereby created to assist the PAB in setting standard for Dioxin.

3. Formulate standards and operational procedures for the implementation of the same.
