AS STUDY COUNTERPARTS, COORDINATORS AND
TEAM LEADERS OF THE MILL AND VOLUME
EQUATION STUDIES ON FOREST STOCK MONITORING
SYSTEM (FSMS) UNDER THE ENR-SECAL PROGRAM

The World Bank (WB) funded ENR-SECAL Program of the DENR is going to undertake studies related to Forest Stock Monitoring System (FSMS) which is in fact an off-shoot of the Log Control Monitoring Sytem (LCMS). Two components of FSMS among others are the Mill Study to determine the appropriate cull factor for the different forest management units and the Volume Equation Study to determine initial volume equation for establishing standards as basis for monitoring timber extraction and processing operations.

These studies on FSMS, as a forestry concern, needs the active participation of the Forest Mannagement Service (at the field level) and Forest Management Bureau (at the central level) especially during the actual conduct of these studies in the field ,to wit:
