DENR SPECIAL ORDER No. 98- 434

SUBJECT: AUTHORIZING THE PARTICIPATION OF THE MEMBERS OF THE PHILIPPINE JOINT MANAGEMENT COMMITTEE AND SOME DENR STAFF AND PERSONNEL IN THE SECOND JOINT MANAGEMENT COMMITTEE MEETING OF THE TURTLE ISLANDS HERITAGE PROTECTED AREA ON June 17-19, 1998 IN QUEZON CITY.

In the interest of the service and pursuant to the MOA on the Turtle Islands Heritage Protected Area (TIHPA) between the Governments of Malaysia and the Philippines, the following members of the Philippine Joint Management Committee (JMC) are hereby authorized to attend the 2<sup>nd</sup> Meeting of the Joint Management Committee of the TIHPA on June 17-19, 1998 in Quezon City:
