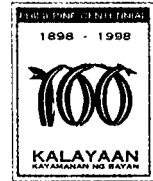

**SUBJECT: CREATION OF A MULTI-SECTORAL
COMMITTEE ON MINING/QUARRYING/
CRUSHING OPERATION IN THE MUNICIPALITY
OF RODRIGUEZ AND SAN MATEO, PROVINCE OF
RIZAL**

Pursuant to DENR Memorandum Order No. 98-06 re: Moratorium on the Acceptance of All New Applications and the Approval of All Pending Applications for Small Scale Mining Permits, Agreements, and Corresponding ECCs in the Municipality of Rodriguez (formerly Montalban), and DENR Memorandum Order No. 98-08 re: Amending DENR Memorandum Order No. 98-06 to include the municipality of San Mateo, and based on prior consultations with concerned organizations/sectors, a Multi-sectoral Committee is hereby created to be composed of the following personnel:
