SUBJECT: Renewal of Deputation of Concession Guards of C. Alcantara &

Sons, Inc. Rm. 7, Lauang, Davao City as Deputy Environment

and Natural Resources Officers (DENROs).

Pursuant to the pertinent provision of DAO No. 41, Series of 1991 and in order to further assist the DENR in curbing, forestalling timber smuggling and all other illegal activities involving destruction and exploitation of the natural resources, the deputation of the following Concession Guards of ALSON, Inc. of Lauang, Davao City as Deputy Environment and Natural Resources Officers (DENROs) under DENR Special Order Nos. 741 and 742 Series of 1995 and Special Order No. 671, Series of 1996 and Special Order No. 97-929 are hereby renewed anew and is not transferable:

By virtue of this deputation, the said Concession Guards of ALSON, Inc. are authorized to detect / investigate violation of forestry laws, rules and regulations and to arrest even without warrant any person who has committed, is committing or is about to commit in their presence any of the criminal offenses defined in chapter IV of Presidential Decree No. 705 as amended, within the territorial jurisdiction of the DENR.

They are also authorized to apprehend / seize the tools, equipment and conveyances used in commission of the offense and the natural resources products extracted / cut, gathered / removed and possessed by the offender(s) in the process of committing the offense. In all instances of detection, arrest and /or seizure. They shall deliver within the period of prescribed by law from the time of arrest and seizure the offender(s) and the seized natural resources product, tools, equipment and conveyances used, and file the appropriate complaint with the concerned officials designated by law, to conduct preliminary investigation and likewise file the information in court through the CENRO/PENRO/RED concerned.

They are further authorized to administer oath and to take acknowledgment in official matters connected with this deputation and to take testimony in official investigations conducted under the authority of the aforecited laws as amended, and it's implementing rules and regulations

Furthermore, they shall assist the Field Operations Office in the collection and validation of intelligence information, enforcement of natural resources laws, rules and regulations, and in the conduct of environment and natural resource information and education campaign such as public meetings / assemblies and other extension activities of the DENR in coordination with it's officials / personnel and/or private agencies in similar works.

They shall submit to the office of the undersigned a monthly accomplishment report using the standard reporting form provided under DENR A. O. No. 41, Series of 1991.

This deputation is not transferable and only authorizes the above mentioned Water District General Managers members with the power and authority conferred herein as recommended by the undersigned.

This deputation order takes effect immediately and will expire on December 31, 1998 or unless sooner revoked or terminated by this office.
