DENR SPECIAL ORDER
NO. 99- 1060

SUBJECT: DEPUTATION OF OFFICERS AND ENLISTED PERSONNEL OF THE FIRST SCOUT RANGER REGIMENT OF THE PHILIPPINE ARMY AS ENVIRONMENT AND NATURAL RESOURCES OFFICERS (DENRO).

Pursuant to the provisions of Executive Order No. 192, dated June 10, 1987, Presidential Decree No. 705, as amended and to pertinent Environment and Natural Resources laws, rules and regulations, the following officers and enlisted personnel of the First Scout Ranger Regiment of the Philippine Army are hereby deputized as Environment and Natural Resources Officers:

As deputized Environment and Natural Resources Officers they shall exercise the following power and authority to wit:

1. Undertake detection, surveillance, monitoring and investigation of violations of forestry, mining, marine and wildlife laws, rules and regulations within their area of operation;
2. Seize or confiscate illegally sourced forest, mineral, marine and wildlife resources or products as well as conveyances, tolls or equipment used in the commission of the offense and to deliver or turn-over said resources or products as well as the conveyances used to the nearest CENRO/PENRO/RED Office in the area;
3. Effect arrest even without warrant in appropriate cases as provided under Section 6, Rule 113 of the Rules of Court, specifically:

- (a) When, in his presence, the person to be arrested has committed, is actually committing , or is attempting to commit an offense;
- (b) When an offense has in fact just been committed, and he has personal knowledge of facts indicating that the person to be arrested has committed it;

The person arrested without a warrant shall be forthwith delivered to the police station or jail and he shall be processed in accordance with Rule 112, Section 7 of the Rules of Court.

- 4. Administer oath or take acknowledgement on official matters in connection with the discharge of his functions as DENRO and to take or receive testimony in the course hereof;
- 5. Assist in the conduct of environment and natural resources information and education activities in coordination with the CENRO and local government units concerned;
- 6. Submit to the CENRO in his area of responsibility a monthly accomplishment report following the format prescribed in DENR DAO No. 41, series of 1991.

Any violation of the terms and conditions or provisions of this deputation shall automatically revoke or cancel this authority, without prejudice to any criminal or civil liability which the said DENRO maybe held liable under pertinent laws or regulations.

This deputation is non-transferable and shall be valid for a period of one (1) year from the date hereof unless sooner revoked or terminated by this Office.
