SUBJECT: AUTHORIZING THE VALIDATION OF THE REPORTED ANNUAL ACCOMPLISHMENTS OF DENR 1998 PROGRAMS AND PROJECTS

In the interest of the service and in line with the periodic activity of coming up with the most accurate, reliable and valid annual accomplishments of DENR programs and projects, the validation of reported annual accomplishments of 1998 programs and projects shall be conducted on February 8 – 22, 1999.

This shall cover all DENR 1998 programs and projects with focus on MUST KRAs, OTHER KRAs and Performance Commitments to the President. Utilizing both office verification and site validation, the annual validation shall be conducted in all regional office levels (CENRO, PENRO and Regional Technical Services) by the following designated teams under the supervision of an overall coordinating team. Sectoral representatives from regional offices shall also compose the validation team. This will afford field personnel the opportunity to carry out regional cross visits and enrich their learning experience.
