SUBJECT: AUTHORIZING THE GRANTING OF HONORARIA TO PERSONNEL INVOLVED IN THE LAND ADMINISTRATION AND MANAGEMENT PROGRAM-INTER-AGENCY COORDINATING COMMITTEE (IACC-LAMP)

In the interest of the service and in accordance with the approved Work and Financial Plan for CY 1999, the Inter-Agency Coordinating Committee created pursuant to Executive Order No. 192, to prepare and coordinate implementation of the Land Administration and Management Program (LAMP), shall provide honoraria to involved officials and personnel of its member-agencies.

Personnel from these offices who have rendered services in addition to their regular duties, in the preparation and coordination of this Program/Project as listed in "Annex A" hereof are authorized to receive corresponding honoraria effective October 01, 1999 to December 31, 1999.

As such, the honoraria to be paid to each personnel shall conform with the provisions of DBM NCC No. 75, Series of 1995, prescribing the guidelines and procedures for the granting of honoraria to government officials and employees. Funds for this purpose shall be charged against the funds of the LAMP-IACC, subject to the usual accounting and auditing rules and procedures.

This Order takes effect immediately.
