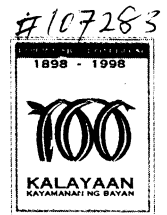

In the interest of the service, the conduct of the following activities in support of this years celebration of the WOMENS MONTH, this March and succeeding months are hereby authorized:


