DENR SPECIAL ORDER NO. 99-325: Series of 1999

SUBJECT

CREATION OF A TASK FORCE TO **INVESTIGATE** THE SYNDICATED LAND SPECULATION AND APPARENT FALSIFICATION AND/OR ALTERATION OF SURVEY PLANS AND OTHER DOCUMENTS IN **CONNECTION** WITH **COVERED BY OCT NO. 5609 IN THE NAME OF FRANCISCO** ABRILLE **JUNA LOCATED** MATINA, DAVAO CITY.

In the interest of the service and in connection with the DENR's "OPLAN Anti-Fake Title", a Task Force on OCT No. 5609 is hereby created to be composed of the following:

The Task Force is hereby authorized to perform the following:

- 1. Conduct an in-depth investigation on several petitions numbering about thirty two (32) attacking the validity of OCT No. 5609 issued to Francisco Villa Abrille Juna through Decree No. 21484 issued by the then Court of First Instance of the District of Davao, 16th Judicial District, Department of Mindanao and Sulu, United States of America and which title was registered in the Registration Book of the Register of Deeds of Zamboanga on June 28, 1916, which lots covered thereby are located in Matina, Davao City;
- 2. Scrutinize further all available pertinent legal documents that led to the issuance of OCT No. 5609 and all its derivative titles;
- 3. Conduct background check on petitioners allegedly construed as syndicated groups and land speculators;
- 4. Investigate the apparent falsification and/or alteration of some survey plans and other documents;

- 5. Issue subpoena <u>duces tecum</u> and subpoena <u>ad</u> testificandum to compel attendance of parties and their witnesses and production of documents; and
- 6. Perform such other activities necessary to achieve the desired objective.

All DENR officials and personnel in the Regional Office XI, the PENROs and CENROs concerned are hereby ordered to extend full support, cooperation and assistance to the Task Force.

All expenses incurred in pursuance of this activity should be charged against OSEC funds subject to the usual accounting and auditing rules and regulations.

The Task Force shall submit its final report and recommendations within fifteen (15) days from termination of this investigation.
