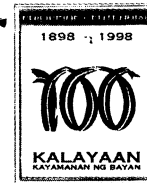

SUBJECT : AUTHORIZING THE CONDUCT OF A TWO-DAY WORKSHOP ON THE REVIEW AND FORMULATION OF AN IMPROVED REFORESTATION SCHEME FOR THE LOW-INCOME UPLAND COMMUNITIES PROJECT

In the interest of the service and in view of the proposed 12-month project extension, the Low-Income Upland Communities Project (LIUCP) is hereby authorized to conduct a two-day **Workshop on the Review and Formulation of an Improved Reforestation** scheme to be used for the reforestation activities during the extension.

The workshop which will be held on April 22 – 23, 1999 at the Danarra Hotel and Restaurant shall have the following objectives:

- a) To review the existing reforestation scheme of the Project and identify some areas that need improvement;
- b) To identify measures of enhancing community role in the protection and maintenance of plantation and reducing government inputs in reforestation; and,
- c) To agree on ways of utilizing reforestation activities as a means of ensuring food security and not just oriented towards watershed rehabilitation and protection.
