Others who will be identified later and who possess the desired qualifications to become members of the Technical Resource Pool will be covered by a separate special order.

The above mentioned officials and retired DENR directors shall serve as members of the DENR-NRDC Technical Assistance Teams and shall work as consultants or consultants on on-call basis for foreign assisted and special projects, resource speakers, lecturers and panelists in various trainings, seminars and workshops. Their expertise shall be utilized by the DENR specifically by the Environmental Management Bureau in the review of EIA/EIS of environmental critical projects.

A work station shall be designated and provided for the members of the TRP for them to be able to work effectively.

In-service members of the TRP when working as members of the Review Committee shall be entitled to compensation and benefits commensurate to their positions as contained in DENR Memorandum Circular No. 99-01 dated January 27, 1999, and such other benefits prescribed under other appropriate rules and regulations.

Director Rosalio B. Goze is hereby authorized and directed to lead the initial members of the TRP to be determined on their time availability in the review of ongoing EIA/ EIS projects together with their counterpart consultants in the Review Committee contracted by the DENR-EMB.

This Order takes effect immediately and shall remain in force until revoked by subsequent order.
