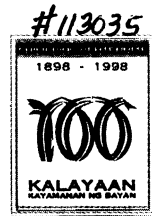

SUBJECT : AUTHORIZING THE CONDUCT OF A WRITESHOP FOR PACKAGING OF PROGRAM/PROJECT PROPOSALS FOR THE DEVELOPMENT OF BIODIVERSITY SITES WITHIN THE COASTAL AND MARINE ENVIRONMENT OF THE COUNTRY IN PAGADIAN CITY ON MAY 24 TO 29, 1999.

In the interest of the service and in view of the need to access financial support from external sources in order provide support to the conservation and development of "biodiversity" sites within coastal and marine environment of the country, the conduct of a "writeshop" on packaging program/project proposals for the development of priority watersheds, rivers, wetlands and other coastal, and marine areas is hereby authorized. The aforementioned "writeshop" shall be held in Pagadian City on May 24 to 29, 1999 to achieve the following objectives:

1. To package a program proposal for the development of critical biodiversity sites within the coastal and marine environment of the country;
2. To prepare/formulate site based project proposals for the development of critical biodiversity sites within the coastal and marine environment of the country;
3. To train DENR central and field personnel in formulating /developing project proposals;
4. To improve the capability of DENR personnel in using new "tools or instruments" for program/project evaluation or assessment like Problem Tree and Fishbone Analyses, LOGFRAME and Goal Oriented Project Planning; and
5. To gather and update DENR data base on marine and coastal environment management.

The writeshop shall be participated by the following:

1. One (1) Representative from ERDS of Regions 1,2,3,4,5,6,7,8,9,10,11,12 and 13 and one (1) from the PENRO/CENRO where the proposed biodiversity site is located)	26
2. One (1) Representative EACH from FMB, EMB, PAWB and ERDB	4
3. Representatives from SCO, FASPO and OSEC (Resource Persons and Consolidators)	10
4. Secretariat from the Region IX	<u>10</u>
TOTAL	50

Expenses to be incurred in the conduct of said workshop shall be chargeable against CEPCO or other DENR funds allotted for the development of biodiversity sites. Transportation of Regional and Central Office participants shall be chargeable to their respective Offices. All expenses shall be subject to the usual accounting and auditing rules and regulations.

This Order shall take effect for the purpose herein specified.
