
They are likewise expected to submit to the Secretary, copy furnished the Undersecretary for International Commitment and Local Government Affairs, a comprehensive report on the workshop outputs.

The Mindanao and Palawan regions are enjoined to set aside Php50,000 each to cover the expenses to be incurred during the meeting, chargeable against their respective 10% Contingency Fund of the Secretary.

The concerned regions shall be notified later on the arrangements regarding the transfer of said amount for the aforementioned purpose.

The participants shall be allowed to claim reasonable transportation expenses chargeable against the funds of their respective offices, subject to the usual accounting rules and regulations.

This Order shall take effect immediately.
