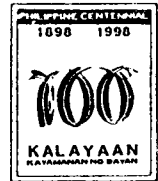

SUBJECT : RECONSTITUTING AND STRENGTHENING THE TECHNICAL WORKING GROUP (TWG) FOR THE PRESIDENTIAL COMMISSION FOR THE INTEGRATED CONSERVATION AND DEVELOPMENT OF THE SULU AND CELEBES SEAS (PCICDSCS) WITHIN THE DENR.

Proclamation No. 1028 provided for the declaration of the entire Sulu and Celebes Seas as Marine and Coastal Integrated Conservation and Development Zone (MCICDZ). To realize this declaration, the Presidential Commission for the Integrated Conservation and Development of the Sulu and Celebes Seas (PCICDSCS) was created mandating the DENR Secretary as the Chairman of the Commission. However, in view of the recent reorganization of DENR support offices, and in order to effectively deliver the services called for, to include the preparation and formulation of action plans, implementation, coordination and reporting and monitoring of activities of the Commission, the following personnel shall compose the Executive Committee / Technical Working Group (TWG) within the DENR.

Herein designated DENR officials shall perform their functions in addition to their present work load. The Sub-Committees shall:

1. Spearhead the implementation of the programs/projects/activities within their respective areas of jurisdiction, in cooperation with appropriate persons, agencies and organizations;
2. Submit progress reports (following completed staff work standards) to the Chairperson of the PCICDSCS-TWG, Attention: The Executive Officer;
3. Perform other related tasks as may be assigned by the Chairperson of the PCICDSCS-TWG.

Expenses to be incurred by the involved personnel in connection with the foregoing activities shall be funded by the CEP/Sulu-Celebes Seas Commission Funds, subject to the approved work plans and existing accounting and auditing rules and regulations.

This order shall take effect immediately.
