The EXECOM shall undertake exhaustive review of relevant reports/studies submitted and direct/coordinate all efforts towards the resolution of the controversy/issue on land classification status of Quezon City; and submit report with their recommendation to the Secretary, DENR.

The TWG, under the direction of the EXECOM shall be responsible in sourcing and initial evaluation of needed information and documents, e.g. certified copies of titles decrees, court decisions, etc. needed in the accomplishment of the subject task for submission to the EXECOM; and perform other related work as directed.

The EXECOM and TWG, are authorized to request the assistance of any Office, official or employee of concerned government and other agencies in pursuance of this Order.

Expenses incurred shall be charged against the funds of their respective offices, subject to accounting and auditing rules and regulation.

This Order takes effect immediately and revokes all orders inconsistent herewith.
