The participants are entitled to claim from their respective offices the amount of **four thousand five hundred pesos (P4,500.00)** for CES Incumbents and **three thousand six hundred pesos (P3,600.00)** for CENROs and Division Chiefs, **all payable to the DENR Cashier**. These shall be used to defray all review-related expenses including food and accommodation of the participants, training staff and resource persons, supplies and materials, honorarium of resource persons and reproduction services. In addition, the participants are also entitled to claim the amount of **five hundred pesos (P500.00)** payable to CESB, as payment of the MATB admission fee.

Their attendance to the MATB Review Class and MATB Special Examination shall be on official time. The travelling and transportation expenses of the participants, training staff and resource persons from DENR shall be charged against their respective offices. All the above expenses are subject to the usual auditing and accounting rules and regulations.
