The participants are expected to prepare the Country Papers needed for the 2nd BIMP-EAGA WGM in Indonesia and report on the Status of Major Agreements reached during the 8th TWG Meeting on F/E. They shall likewise assess the doable/banner projects of the TWG for CY 2000-2004 and prepare a paper on the Role of EAGA-Member Countries on Other International Agreements Pertaining to Environment in compliance to the instruction of the P-EAGA Signing Minister during the Post SOM/MM Meeting.

Upon completion of the meeting-workshop, a report shall be submitted to the Secretary, copy furnished the Undersecretary for International Commitment and Local Government Affairs.

A registration fee of Php 4,500.00 shall be charged each participant to cover the expenses on food, accommodation, kit and supplies during the whole duration of the meeting-workshop, chargeable against funds of BIMP-EAGA allocated in their respective offices subject to the usual accounting and auditing rules and regulations.
